LAWYER REFERRAL SERVICES AND LEGAL RESOURCES

When a legal problem arises it is important to know where to turn to solve your problem. In your effort to do this you need to answer the following questions:

- (1) What is the problem and what do you want as a solution?
- (2) What are the facts surrounding the problem (who, what, when, where, why)?
- (3) How can you prove the facts (what evidence is there)?
- (4) Is there a law that will allow you to get what you want?
- (5) How do you want to resolve the problem (counseling, negotiation, hire attorney, small claims, civil court)?
- (6) Is it worth the fight? Sometimes the time, expense, impact on family, etc. just aren't worth the hassle even if everything else is in your favor.

This handout will assist you in finding the legal assistance you need in an attempt to answer these questions and, hopefully, resolve your problem. If you know that you need a lawyer and can afford one, use Sections I and V. If you are not sure or cannot afford one, use Sections II-IV.

PHONE BOOK YELLOW PAGES

Listings are under "Attorneys" or areas such as "Attorneys-Divorce." Ads usually include areas of law practiced and often describe qualifications and special services available, such as foreign language or free initial consultations. Yellow page listings are paid advertisements.

MARTINDALE-HUBBELL LEGAL DIRECTORY

Lists the name, address, and phone of law firms, gives resumes of lawyers doing business in any particular city, and tells what areas of law they practice. Also gives a summary of the laws of each state and country.

Nevada residents who are 60 or older are eligible. There is no charge for services; however, donations are accepted. Clients are responsible for filing fees and court costs. Counselors make visits to home-bound senior citizens when necessary. They handle simple wills, social security disputes, health care planning, living wills, powers of attorney, landlord/tenant disputes, small claims court instruction, homesteads, affidavit of entitlements, intervention of elder abuse matters, legal advice, information and referrals. They do not handle traffic citations, criminal matters, malpractice, divorces, bankruptcy, living trusts, fee generating cases, guardianship, or real estate transactions.

The NJC helps residents of Clark County resolve conflicts, at no cost, through a comprehensive information and referral program and through mediation services. NJC counselors are familiar with local resources and assist citizens by defining the dispute and directing the citizen to an appropriate resource. NJC provides mediation services for neighborhood, family, consumer/merchant, employer/employee, landlord/tenant, and doctor/patient disputes. They will not take cases involving violence, or involuntary participation in the mediation. NJC will not provide legal advice or attorneys. There is no income requirement.

Section VI - QUESTIONS TO ASK YOUR LAWYER

Your relationship with your lawyer is important. You must trust your lawyer and you must be open and honest with your lawyer. Ask questions to learn about your lawyer, your lawyer's practice, and how your lawyer intends to handle your case. You should know the answers to the questions below, and have a good start on the six questions on page one of this handout after your first meeting with your lawyer.

1. Do I really need a lawyer or should I go somewhere else for help?
2. Where did you go to law school; where are you licensed; how long have you been practicing law?
3. What percentage of your practice is devoted to cases like mine; what experience do you have in this area of law; what are your main areas of practice?
4. Will you personally work on my case; what parts will you delegate to an associate or Paralegal assistant?
5. What documents or other information do you need from me?
6. Is there any other evidence that I can help you get?
7. Are there any non-legal issues you would advise me to consider?
8. How will you keep me notified about the progress of my case?
9. Will you be available to me by phone or for a follow-up appointment if I need to talk with you again?
10. How long should it take to finish my case; what might slow it down?
11. Can we settle, negotiate, mediate, or arbitrate my case?
12. What services do you provide for a flat fee; what are your hourly rates?
13. Do you accept contingency fee arrangements; how do they work; what percentage do you keep; What do you include in the base amount that you take a percentage of?
14. What costs can I expect in addition to your fee?

15. Do you require a retainer or deposit in advance; How often do I have to pay you?
16. Can we enter into a written fee agreement?
17. What, roughly is it going to cost?
18. When will I hear from you next?
